### Membership Fees:

### Privileges of Memberships:

1. Ordinary and Life Members shall enjoy all privileges of the Academy.
2. Associate Members and Associate Life Members shall enjoy all the privileges of the Academy except the right to vote and hold office.

### Types of Membership

#### a) Ordinary Members

All current Principals of Government, Government-Aided or Independent Schools may apply.

All former School Principals who go on to serve in the Ministry of Education Headquarters, the National Institute of Education and related organisations, and who remain in leadership positions may also apply. All persons in the National Institute of Education who play a significant role in developing practicing School Principals or Vice Principals may also apply to join as Ordinary members.

**b) Associate Members**

Retired School Principals, practicing Vice-Principals, Principals of ITE, Polytechnics and foreign schools recognized by the Academy, may apply to join as Associate Members. They may not vote or hold office in the Academy.

**c) Life Members\***

Ordinary Members who have been members of the Academy for at least one (1) year may apply to be Life Members.

**d) Associate Life Members**

Life Members who retired from service will automatically become Associate Life Members. They may not vote or hold office in the Academy.
